**Approval of the Minutes of the Committee of the Whole Meeting of July 2, 2018:** Motion by Trustee King second by Trustee Adams to approved the regular meeting minutes. Voice Vote, all in favor: "Aye" none oppose. Motion passes. Hamilton absent.
