President Vershaw called the meeting to order at 7:00 PM. Clerk Bergeson called the roll noting a quorum present and the Pledge of Allegiance was recited.

**Approval of the Minutes of the Regular Meeting of September 10, 2018:** Motion by Trustee Hamilton second by Trustee Adams to approved the regular meeting minutes. Voice Vote, all in favor: "Aye" none oppose. Motion passes. King & Goodman absent.

**Approval and Authorization for Payment of Bills:** Motion by Trustee Adams, second by Trustee Hamilton to approve the bills. Roll call vote as follows: Adams, Hamilton, Heintz, VanDieren: "Aye". Motion Carried. King & Goodman absent.

**Consideration and Approval to address the Corp properties as Hampton:** Clerk Bergeson discussed the Ordinance that was recorded in 1992 in which the Corp properties were annexed into the Village. The properties were addressed from East Moline and given East Moline parcels which has created some confusion. The properties pay Hampton street improvement taxes with an East Moline address. Clerk Bergeson will contact the GIS Department and begin the process of readdressing the properties correctly. Motion was made by Trustee Adams, second by Trustee Hamilton to approve moving forward. Voice Vote, all in favor: "Aye" none oppose. Motion passes. King & Goodman absent.

**Consideration and Approval regarding the Interim Chief's pay:** Clerk Bergeson requested the Interim Chief receive back pay in the amount of the previous Chief. Motion by Trustee Hamilton, second by Trustee Adams to approve the back pay for the Chief from the 10th of September. Roll call vote as follows: Hamilton, Adams, Heintz, VanDieren: "Aye". Motion Carried. King & Goodman absent.

**Consideration and Approval to hire a full time public works employee.** The Board discussed that it was in the best interest of the Village to hire a full time employee for the public works department. Applications will be accepted online and through Village Hall until October 26, 2018. Motion was made by Trustee Adams, second by Trustee Hamilton. Voice Vote, all in favor: "Aye" none oppose. Motion passes. King & Goodman absent.

**Consideration and Approval of the appointment of the new Chief of Police.** President Vershaw made the Interim Chief the appointment of Chief. Chief David Perley is qualified to serve the Village. Chief Perley accepted the position and was sworn in and took Oath given by Clerk Bergeson. Motion was made by Trustee VanDieren seconded by Trustee Hamilton to accept President Vershaw's appointment. Voice Vote, all in favor: "Aye" none oppose. Motion passes. King & Goodman absent.

**Consideration and Approval to donate the surplus vehicle to Arrowhead.** The Ford Crown Victoria, police car was declared surplus and is now being donated to Arrowhead. Motion was made by Trustee Heintz seconded by Trustee Hamilton. Voice Vote: All in favor, "Aye" none oppose, Motion passes. King & Goodman absent.
