**Discussion regarding clarification on zoning for miniature golf course.** President Bornhoeft asked the owner Yoshi, who was in attendance, what his plans were for the property. Yoshi stated that he is trying to allow the course to run itself and get passes. He has pool tables, cornhole bags and will allow the individuals to rent the entire place for themselves. Where the Airbnb camper comes in is, they cover the insurance and marketing. This is a unique idea to get this up and running and not be an empty spot like it has been. The property is zoned C-1. Which does not allow for short term rental. Now you have the option of going to the zoning board to get a special use permit.
