President Bornhoeft called the meeting to order at 6:30 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Hampton Heritage Center. Motion to add Trustee Smice via telephone by Trustee Adams, second by Trustee White. Motion approved by unanimous vote.

Consideration and Approval of the minutes of the meeting August 26, 2024. Motion to approve the minutes by Trustee White, second by Trustee Adams to approve the minutes. Motion carried by unanimous voice vote.

Approval and Authorization for Payment of Bills. Motion by Trustee Adams to approve the bills, second by Trustee Schneckloth to approve the payment of bills. Roll call vote as follows: White, McKay, Schneckloth and Adams: "Aye", Gonzalez and Smice: absent. Motion carried.

Visitors Who Wish to Address the Board: Yoshi Haddon addressed the board regarding a lawsuit that he has filed against the village. Stacy Jones addressed the board asking for more transparency and asking the public for their input on issues. Marilyn Lockwood expressed her concerns regarding the 811 Airbnb.

Lori Rotz addressed the board regarding the age of servers: Lori Rotz has asked that the age to serve liquor at The Logger House be changed from the current age of 21 to 18. She currently has a minor working for her at her other establishment. She would like to employ the minor at the Logger House as well.

Discussion and Consideration of a solution to the Burn Issue: Trustee Smice would propose no burning on Sundays, Mondays and Tuesdays and the last Saturday of the month. Trustee Adams made a motion to table the issue until the Ordinance is brought to council. Second by Trustee White. Motion approved by unanimous voice vote.

Discussion, Consideration and Approval of the Zoning Boards recommendation regarding 811 1st Avenue. Motion made by Trustee Adams second by Trustee Schneckloth. Discussion as follows: Trustee Adams is on the fence with the zoning boards recommendation. Motion to approve zoning boards recommendation: Roll call vote as follows: McKay, Smice and Schneckloth: "Aye" Adams and White: "Nay". Gonzalez absent.

Consideration and Approval of the Ordinance 2024-08 AN ORDINANCE OF THE VILLAGE OF HAMPTON, ROCK ISLAND COUNTY, ILLINOIS, ALLOWING SPECIAL USE OF PROPERTY ZONED R-1. Motion to approve the discussion of the ordinance allowing the special use by Trustee McKay seconded by Trustee Adams. Zoning Board member Mike Klouser attended the meeting to speak on behalf of the zoning meeting. Mr. Klouser stated that the board made the recommendation based on the fact that when Mr. Deines purchased the property it was an established short-term rental. Trustee Adams would like changes to be made to the ordinance stating the zoning boards recommendations: "Special Use will be revoked if property is abandoned, police presence and blight." Clerk to make changes and present to board next council meeting. Motion to table by Trustee Adams, seconded by Trustee Schneckloth. Motion approved by unanimous voice vote.

Consideration and Approval of the Resolution 2024-13 A RESOLUTION IN SUPPORT OF AN ILLINOIS TRANSPORTATION ENHANCEMENT PROGRAM (ITEP) GRANT APPLICATION FOR BICYCLE AND PEDESTRIAN IMPROVEMENTS IN THE VILLAGE OF HAMPTON, COUNTY OF ROCK ISLAND, STATE OF ILLINOIS. Motion to table until next meeting by Trustee Adams until Resolution is presented, second by Trustee Schneckloth. Motion approved by unanimous voice vote.

Consideration and Approval of the Ordinance 2024-07 AN ORDINANCE OF THE VILLAGE OF HAMPTON, ROCKISLAND COUNTY, ILLINOIS, AMENDING THE TITLE 4 COMMUNITY PROTECTION; ATRICLE 8 TRANSPORTATION; SECTION 1 PARKING OF VEHICLES ON PUBLIC WAYS OF THE CODE OF ORDINANCES FOR THE VILLAGE OF HAMPTON, ROCK ISLAND COUNTY, ILLINOIS. Motion to approve the amending of the Ordinance regarding parking made by Trustee White, seconded by Trustee McKay. Roll call vote as follows: White, McKay, Smice, Schneckloth and Adams: "Aye". Gonzalez absent.

Discussion, Consideration and Approval to repair golf disc baskets by the Scott Community College welding instructor. Trustee Adams motioned to table until further information is available regarding the number of baskets in need of repair. Motion was seconded by Trustee Schneckloth. Motion tabled by unanimous voice vote.
