President Vershaw called the meeting to order at 7:00 PM. Trustee Adams called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Hampton Village Hall.

Consideration and Approval of the minutes of the meeting September 9, 2019. Motion made by Trustee King, second by Trustee Bornhoeft. Motion carried by unanimous voice vote.

Consideration and Approval of the minutes of the meeting September 12, 2019. Motion made by Trustee King, second by Trustee Bornhoeft. Motion carried by unanimous voice vote.

**Approval and Authorization for Payment of Bills.** Motion made by Trustee King, second by Trustee Bornhoeft. Roll call: King, Bornhoeft and Adams: "Aye". Motion carried.

Appointment of the new police chief. Motion made by Trustee Adams, second by Trustee King. Motion carried by unanimous voice vote. Discussion: President Vershaw, Terry Engle to be Chief and Interim Chief Costas will be moved to Deputy Chief. Chief Engle will begin September 28, 2019.

Discussion, Consideration and Approval of the Ordinance 2019-831 regarding Water rate increases. Motion made by Trustee Adams, second by Trustee Bornhoeft, rates will increase in November of 2019. Roll Call: Adams, Bornhoeft and King; "Aye", Motion carried.

**Discussion, Consideration and Approval of the Ordinance 2019-830 regarding Sewer rate increases.** Motion made by Trustee King, second by Trustee Adams, rates will increase in November of 2019. Roll Call: Adams, Bornhoeft and King; "Aye", Motion carried.

**Discussion, Consideration and Approval of Agreement with Point & Pay.** Motion by Trustee Adams, second by Trustee Bornhoeft to approve the agreement. Roll Call: Adams and Bornhoeft: "Aye", King: "Nay", President Vershaw: "Aye". Motion carried.

Consideration and Approval to block a portion of 12th Avenue from 6th ST to 8th ST for a block party on Saturday September 28<sup>th</sup>. Resident did not show up, Motion not granted.

Consideration and Approval of charges to Village credit card use policy. Motion made by Trustee King, second by Trustee Bornhoeft. Roll call: King, Bornhoeft and Adams: "Aye". Motion carried.

Consideration and Approval to spend up to \$1,000 for annual IFSI Fall Down and Dirty training: Motion made by Trustee King, second by Trustee Adams. Discussion: Early bird registration before 10/01/19 saves money, hotel, per diem and classes. 7-8 firefighters to go. Roll call: King, Bornhoeft and Adams: "Aye". Motion carried.

Consideration and Approval to replace the men's toilet in the Fire Department. Motion made by Trustee Adams second by Trustee Bornhoeft. Discussion: Chief will do the work. Roll call: King, Bornhoeft and Adams: "Aye". Motion carried.

Consideration and Approval to purchase public education material for the School and Fire Prevention Week. Motion made by Trustee Adams, second by Trustee King. Discussion: Spend up to \$400.00 for Hampton Elementary. Roll call: King, Bornhoeft and Adams: "Aye". Motion carried.
