President Vershaw called the meeting to order at 7:00 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Hampton Village Hall.

Consideration and Approval of the minutes of the meeting October 21, 2019: Motion by Trustee Hamilton, second by Trustee Adams to approve the minutes as with changes. Motion carried by unanimous voice vote.

Consideration and Approval of the minutes of the meeting October 28, 2019: Motion by Trustee Adams, second by Trustee Goodman, to approve the minutes as with changes. Motion carried by unanimous voice vote.

Consideration and Approval of the minutes of the meeting November 4, 2019: Motion by Trustee Adams, second by Trustee Hamilton to approve the minutes as with changes. Motion carried by unanimous voice vote.

Approval and Authorization for Payment of Bills: Motion by Trustee Hamilton, second by Trustee Adams to approve the bills and authorize for payment. Trustee Bornhoeft questioned IMEG engineering cost, if it was being paid out of MFT, yes it is. Motion carried by roll call vote to approve payment of bills.

**Consideration and Approval of the Ordinance 19-833 Levying Taxes.** Motion by Trustee Adams, second by Trustee Hamilton, Motion carried by roll call vote.

**Consideration and Approval of the Ordinance 19-832 Abating Taxes.** Motion by Adams, second by Trustee Bornhoeft. Motion carried by roll call vote.

**Discussion, Consideration and Approval to sign the Informal Conference Board Waiver from Illinois Department of Revenue.** Motion to table by King second by Trustee
Adams to sign the waiver and pay the taxes owed during the amnesty period to avoid further penalties. Motion carried by roll call vote.

Discussion, Consideration and Approval of the payment to McCarthy Improvement in the amount of \$78,13.76. Motion by Trustee Adams, second by Trustee Goodman. Motion carried by roll call vote.

**Discussion, Consideration and Approval of the Verizon quotes for service.** Motion by Trustee Bornhoeft, second by Trustee Hamilton. Clerk will bring definitive numbers and contracts to attorney's attention before next meeting. Motion carried by roll call vote.

**Discussion regarding Employee Health Plan.** The employee health plan expires at the end of the year, the new rate will go up. Clerk Reyes will have more information when it becomes available.

**Discussion, Consideration and Approval of taxing Heritage Center events.** Since the recent audit of the Heritage Center and not taxing properly for events, discussion was made as to whether or not add the taxes into the rental fees or just tax for the event. Motion to table and discuss at a committee meeting made by Trustee Adams, second by Trustee Hamilton. Motion carried by voice vote.

Consideration of setting a meeting at Village Hall with Boy Scouts. Trustee Bornhoeft wanted approval to have a meeting at the Village Hall as the Boy Scouts are interested in local government.

Consideration and Approval of Karl Beatty Acoustic for Toys for Tots. Motion by Trustee King second by Trustee Hamilton to approve Karl Beatty Acoustic for Toys for Tots in the amount of \$200.00 for 3 hours. Motion passed by roll call vote, Adams vote no.

**Discussion of new memorial at Hampton Park.** There is someone interested in placing a memorial bench at the park in memory of a loved one. This needs to remain uniform with the

benches already in the park. A committee meeting to discuss in detail the way they would like to handle placement of benches and trees.

**Discussion, Consideration and Approval of NIU Center for Government Studies representatives to present strategic planning at future board meeting.** Trustee Bornhoeft feels that they are just going to take our money, Trustee King wants to stay with the current strategic board. Motion by Trustee Goodman second by Trustee King. Motion failed by roll call vote.

**Discussion of TIF district options.** Trustee Adams is looking into other options to help Platinum stay in Hampton and grow. Platinum does not have enough land and would like to expand. They are currently in a TIF and we would like to help them stay in the Village.

Discussion, Consideration and Approval of Bi-State to conduct Low-Medium Income Study, necessary for USDA Grant. Trustee Adams is trying to look for resources to help the infrastructure within the Village by way of Grants and Bi-State will conduct a free income study. Motion by Trustee Bornhoeft second by Trustee Goodman. Motion passed by unanimous voice vote.

Motion by Trustee King second by Trustee Goodman. Motion failed by unanimous voice vote.

**Discussion, Approval and Consideration of Surplus Property.** The fire department command vehicle has been replaced and there is no use for the old command vehicle. Motion by Trustee King second by Trustee Hamilton to write a resolution and deem the vehicle surplus. Motion passes unanimous voice vote.
