President Vershaw called the meeting to order at 7:00 PM. Clerk Reyes called the roll noting a quorum present. The Pledge of Allegiance was recited.

The meeting to order to discuss the following:

- Discussion, Consideration and Approval of the FY 2021-2022 Budget; Discussion regarding Revenues, Expenses and Salaries.
- Public Works, Streets and Parks: Supervisor McKay stated that the backhoe needs attention. We should also consider purchasing flood pumps or finish flood gate. Last flood we borrowed flood pumps and IEMA provided the pumps. The park equipment we are getting we will need to rent a mini excavator to dig up.
 We also need to consider the trees that need to come down. We needed to fix pump house roof and replace our master meter.
- **Fire Department:** The generator needs replaced and the roof is leaking. Turnout gear and other equipment, as well as attention to current vehicle "wonder wagon" #98.

- **Police Department:** looking at \$250,000 in wages for a 40 hour work week. Omit all overtime.
- Heritage Center: the roof and ceiling needs replaced from the derecho that we
 had. One possible solution is to add sound boards that will reduce the acoustics
 and eliminate the painting of the ceiling. Go for quotes for roof. Board is also
 looking at reducing a position to help offset budget deficit.
- Administration: Village Hall is in need of repairs, mold in basement, foundation
 is cracked in basement, water standing, lighting, soffit is damaged, pillars are
 rotting and it needs tuck pointing. Suggestion to move Clerk office to Heritage
 Center or empty office at Police Department. Accountant and Clerk are working
 towards the implementation of the new software. Must recreate the last year,
 recreate invoicing and payroll.
- Will schedule next budget meeting once new program is completely balanced and implemented.

There being no further business, it was motioned by Trustee Adams, second by Trustee Bornhoeft, to adjourn until the next regular meeting. All in favor: "Aye". None opposed. Motion carried. The meeting was adjourned at 8:51 PM.

Consideration and Approval of the minutes from the meeting March 12, 2021.

Acknowledgement of Visitors Who Desire to Address the Board. Pam Goff would like to know if there is anything they can do to help keep the police dept. Trustee Bornhoeft said that we are looking at Budget as we have to wait 2 years to ask for a public safety fee on the referendum. Another resident would like information included in water bills, stated they were not aware of the event Fields of Pizza had for the police dept. Clerk Reyes stated that it was a entire page of the newsletter as well on Facebook page.

Presentation of the donation from Bob Fields to the Police Department. Bobby Fields owner of Fields of Pizza and Hampton resident, donated 20% of sales from March 11th to the Hampton Police Department. Mr. Fields presented a check for \$1000.00 to the Chief. Chief Tone stated "Thank you Mr. Fields for your kindness and you are one of Hampton's best."

Consideration and Approval of chemicals from Quality Chemical. The quote is actually from Eagle Chemical, scrivener's error on the Agenda. Motion to approve by Trustee King, second by Trustee Adams to approve the quote. Motion approved by roll call vote as follows: Bornhoeft, King, VanDieren, Goodman and Adams: "Aye" Motion passed.

Consideration and Approval of removal of trees. Supervisor McKay stated that the trees in Munson park need to come down in order for the equipment to go in, in the amount of \$8300.00. Trustee VanDieren asked if more quotes were received, no other quotes were given. Motion to approve by Trustee King second by Trustee Bornhoeft, Motion approved by roll call vote as follows: Bornhoeft, King, Goodman and Adams: "Aye" VanDieren: "Nay" Motion passed.

Discussion, Consideration and Approval for sound barriers at the HC. Motion to table until President Vershaw could attend by Trustee Adams second by Trustee VanDieren to table. Motion approved by unanimous voice vote.
