President Bornhoeft called the meeting to order at 6:30 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Consideration and Approval of the minutes from the meeting February 27, 2023. Motion by Trustee White, second by Trustee Adams. Motion approved by voice vote.

Consideration and Approval of the minutes from the March 1, 2023 Budget Meeting. Motion to approve the minutes by Trustee Adams, second by Trustee Gonzalez. Motion approved by voice vote.

Consideration and approval of payment of Bills. Motion by Trustee Adams, second by Trustee Gonzalez to approve the bills. Roll call as follows: White, Schneckloth, Gonzalez and Adams: "Aye". Smice and McKay absent. Motion approved.

Acknowledgement of Visitors Who Desire to Address the Board. Gerry Kruder and Carl Hunter, residents of Lighthouse Association. Mr. Kruder is the President, they would like to express concerns regarding a neighboring property. Many complaints regarding abandoned cars and junk. A letter was sent some time ago to the resident and sent to police department. No follow up. Chief Tone will address this, if the situation is not resolved, Building Inspector will be contacted.

Resident Elliott Stone addressed the board with concerns regarding a lot of dead ash trees along the bike path as well as the trash not being emptied all winter. Also put speed limit signs in the village "20 MPH" so that it can be enforced. Public Works Supervisor Toalson stated that the previous supervisor removed a lot of the signs. Board directed Toalson to put the signs back. Mr. Stone also would like to know when the roads from the main breaks are going to be fixed? There is lots of holes in the streets. Trustee White stated that we are waiting on Bob's Blacktop to contact us.

Consideration and Approval of Ordinance 2023-03 Amending Section 4.8.11 Operation of Golf Carts on Public Streets in the Village. Motion to amend to include UTV's. Motion by Trustee White, second by Trustee Gonzalez. Roll call as follows: White, Schneckloth, Gonzalez and Adams: "Aye". Smice and McKay absent. Motion approved.

Consideration and Approval regarding the quote from Ferguson for N360 hardware. Clerk Reyes stated this is the software we currently use to read meters, this is an annual fee. Motion by Trustee Adams, Second by Trustee Gonzalez. Roll call as follows: White, Schneckloth, Gonzalez and Adams: "Aye". Smice and McKay, absent. Motion approved.
