President Bornhoeft called the meeting to order at 6:30 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Heritage Center.

Consideration and Approval of the minutes from the meeting March 13, 2023. Motion by Trustee Adams, second by Trustee White. Motion approved by voice vote.

Consideration and approval of payment of Bills. Motion by Trustee Adams, second by Trustee Smice to approve the bills. Roll call as follows: White, McKay, Smice and Adams: "Aye". Schneckloth and Gonzalez absent. Motion approved.

Acknowledgement of Visitors Who Desire to Address the Board. No one addressed the board.

Consideration and Approval of Ordinance 2023-04 AN ORDINANCE AMENDING TITLE FIVE "WATER REGULATIONS", ARTICLE 1 "VILLAGE WATER DEPARTMENT", OF THE VILLAGE CODE OF HAMPTON, ROCK ISLAND COUNTY, ILLINOIS, IN THE VILLAGE OF HAMPTON, ILLINOIS. Motion by Trustee White, second by Trustee McKay to raise the base minimum water rate of 2000 gallons from \$19.14 to \$19.64 and from \$5.55 to \$5.75 per 1000 gallons after. Roll call as follows: White, McKay, Smice and Adams: "Aye". Schneckloth and Gonzalez absent. Motion approved.

Consideration and Approval of Ordinance 2023-05 AN ORDINANCE AMENDING TITLE SEVEN "SEWER USE ORDINANCE", CHAPTER B "WASTEWATER SERVICE CHARGES AND INDUSTRIAL WASTE COST RECOVERY", ARTICLE 1 "WASTEWATER SERVICE CHARGES", OF THE VILLAGE CODE OF HAMPTON, ROCK ISLAND COUNTY, ILLINOIS, IN THE VILLAGE OF HAMPTON, ILLINOIS. Motion by Trustee Adams, second by Trustee Smice to raise the base minimum sewer rate of 2000 gallons from \$21.71 to \$22.21 and from \$6.50 to \$6.75 per 1000 gallons after. Roll call as follows: White, McKay, Smice and Adams: "Aye". Schneckloth and Gonzalez absent. Motion approved.

Consideration and Approval of the Resolution 2023-01 to declare the 2005 Ford F550 Super Duty as surplus. Motion by Trustee Adams, second by Trustee White to declare the 2005 Ford F550 as surplus. Consideration and Approval of the Employee Policy. Motion to approve the Employee Policy that encompasses all policies. Motion by Trustee Adams, second by Trustee McKay. Roll call as follows: White, McKay, Smice and Adams: "Aye". Schneckloth and Gonzalez absent. Motion approved.

Discussion of the deficit in FY 2023-2024 Budget. Discussion regarding the deficit in the budget. Chief Tone gave the board options to save the village money. Currently the budget is \$409,000. Hampton does not have the revenue that they obtained in FY22-23, ARP fees, Cure money and the Rapid City Police Contract. New proposal is with minimal coverage \$304,000 a full time chief and part time officers that cover when their other job allows. Chief Johnson made some cuts to his budget bringing training to a minimum. The board discussed the deficit between revenues and expenditures for the Heritage Services, possibility Next council meeting will lightly touch the deficit with a budget meeting scheduled to complete.
