Acknowledgement of Visitors Who Desire to Address the Board. Tom McKay, President of the Historical Society. Presented the board with proposal from Renaissance Restoration to fix the monument next to Village Hall. The NE corner is pulling away from the foundation, it is in an emergency state of repair. The proposal is for \$20,000, they have quite a bit of experience in this. Tom McKay understands this is an expense for the Village, he would like to donate \$15,000 to help with the costs. President Bornhoeft noted that was a wonderful and generous offer.
