President Bornhoeft called the meeting to order at 6:30 PM. Deputy Clerk Coberley called the roll noting a quorum was present. The Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Approval of the Meeting Minutes of August 25, 2025. Motion to approve the minutes made by Trustee Adams seconded by Trustee Culver. Trustee Adams noted scrivener errors. Motion to rescind made by Trustee Adams, seconded by Trustee Culver. Motion to approve with changes made by Trustee Adams, seconded by Trustee Culver. Motion approved with a unanimous "Aye" vote.

Approval of the Committee Meeting Minutes of September 2, 2025. Motion to approve the minutes made by Trustee Adams, seconded by Trustee Gonzalez. Motion approved with unanimous "Aye" vote.

Approval and Authorization for Payment of Bills. Motion to approve payment of bills made by Trustee Adams, seconded by Trustee White. Motion approved by roll call vote as follows: Culver, Gonzalez, Adams, Klouser and White: "Aye". Trustee Johnson absent. Motion carried.

Visitors who Wish to Address the Board (3-minute time limit). No visitors addressed the board.

Consideration and Approval of the Quote from Titan Machinery for Inspection and Repairs to the Backhoe. Public Works Director Toalson notified the Board that the backhoe is due for routine inspections and there was also work needed to repair the parking brake. Motion to approve made by Trustee Adams, seconded by Trustee White. Motion approved with a role call vote as follows: Adams, Gonzalez, Culver, Klouser and White voting "Aye". Trustee Johnson absent.

Discussion of the recodified Code of Ordinances. Clerk Reyes informed the Board that the newest draft of the recodified Code of Ordinances has been received and is ready for review.

New Business & Committee Reports

Streets and Alleys: Trustee Culver stated that she will be reaching out to MidAmerican regarding streetlights in the Village.

Public Safety: Trustee Johnson was absent.

Sheriff: absent.

Fire Rescue Chief Report: Chief Johnson stated that there were 6 smoke/fire and 7 medical calls in the last week. He has sent the Hampton Firefighters to Silvis for additional medical training. He reported that the ISO rating has improved and is the best rating in Hampton's history. Chief Johnson anticipates the arrival of the new fire engine at the end of September or beginning of October.

Finance: Trustee Adams asked the Board to go over the most recent copy of the IML magazine for information regarding Non-Home Rule tax as well as the sales tax.

Administration, Insurance and Code Enforcement: Trustee Klouser had nothing to report.

Public Works: Trustee White thanked the public works department for their work on the water main breaks that took place in the afternoon and overnight September 5-6, 2025.

Public Works Director: Director Toalson updated the Board on the replacement of the valve by the cemetery on 4th street. He also discussed the water main breaks in the afternoon and overnight September 5-6, 2025.

Parks and Heritage Center: Trustee Gonzalez thanked the members who attended the Committee Meeting at the Heritage Center.

Village Clerk: Clerk Reyes discussed the new locks on the Village Hall building.

Deputy Clerk: Deputy Clerk Coberley stated that she is still trying to increase the number of residents who have signed up for notifications.

President's Reports and Comments: President Bornhoeft thanked the public works department for their hard work on the water main breaks.

Being no further business, Motion by Trustee Adams, second by Trustee White to adjourn. Motion passed by unanimous voice vote. Meeting adjourned at 7:12 PM.
