President Bornhoeft called the meeting to order at 6:30 PM. Clerk Coberley called roll call, noting a quorum was present. The Pledge of Allegiance was recited. The meeting was held at the Village Hall.

**Approval of the Meeting Minutes of September 28, 2025.** Motion to approve made by Trustee Adams, seconded by Trustee Klouser. Motion was approved with a unanimous "Aye" vote.

**Approval of the Committee Meeting Minutes from October 2, 2025.** Motion to approve by Trustee Adams, seconded by Trustee Gonzalez. Motion approved with a unanimous "Aye" vote.

**Approval and Authorization for Payment of Bills**. Motion to approve payment of bills made by Trustee Adams, seconded by Trustee White. Motion approved by roll call vote as follows: White, Klouser, Culver, Johnson, Gonzalez and Adams all "Aye". Motion carried.

**Visitors who wish to address the Board (3-minute time limit).** Michelle Reyes and JD from Hutchinson Engineering discussed the progress on the Safe Routes to School Grant application.

Breon Hickman, with TKO Fireworks out of East Moline, presented the Board with a proposal to bring a retail fireworks store to the Village.

Consideration and Approval of the Quote for RMA Insurance for 2026. Motion to approve made by Trustee Adams and seconded by Trustee White. Motion approved by roll call vote as follows: White, Klouser, Culver, Johnson, Gonzalez and Adams all "Aye". Motion carried.

Consideration and Approval of the Corporate Authorization Resolution with Blackhawk Bank to edit the Clerk's name and remove former Trustee as signer. Motion to approve made by Trustee Adams, seconded by Trustee Klouser. Motion approved by roll call vote as follows: White, Klouser, Culver, Johnson, Gonzalez and Adams all "Aye". Motion carried.

**Discussion regarding the recodified Code of Ordinances second reading.**Trustee Klouser discussed the ordinances regarding weed management, parking, derelict vehicles, leash laws and motorized bikes. Trustee Adams discussed the issues residents have had with mini-motorcycles on the streets.

**Discussion, Consideration and Approval mulch/ground cover for park at 6<sup>th</sup> Street and 3<sup>rd</sup> Avenue.** Public Works Director Toalson stated that the mulch/ground cover has already been arranged for Spring 2026. Trustee Adams motioned to table the topic until Spring. Seconded by Trustee Gonzalez. Motion approved with a unanimous vote "Aye".

**Discussion regarding the new fire rescue 2998 sitting outside the Fire Department.** Fire Chief Manion informed the Board that the new 2998 will be stored inside the fire station within a week.

**Discussion regarding equipment, procedures and other OSHA compliance.** Trustee Adams discussed procedures that will help to ensure OSHA compliance as well as grants that are available for equipment upgrades if needed.

**Discussion regarding Hampton Days.** Motion made by Trustee Adams to move the discussion to a later date. Seconded by Trustee Culver. Motion carried with a unanimous vote "Aye".

## **New Business & Committee Reports**

**Streets and Alleys**: Trustee Culver had nothing to report. Director Toalson asked that if residents see issues with the roads, please email or call the office so they can stay ahead of repairs before winter.

**Public Safety**: Trustee Johnson nothing to report.

Sheriff: Absent.

**Fire Rescue Chief Report:** Chief Manion informed the Board that the new fire engine was due to be delivered on Monday night. The old fire engine would be ready for the surplus process.

Public Works: Trustee White had nothing to report.

**Public Works Director**: Director Toalson had nothing to report.

**Deputy Clerk:** Deputy Clerk Coberley informed the Board that she had been in contact with Conrad Disposal regarding stickers for extra trash and large items. The extra trash stickers will be \$2 each, and the large item stickers will be \$15 each, and Conrad will be providing the stickers to the office within the next couple of weeks.

**President's Reports and Comments**: President Bornhoeft would like to begin the list for the invitations for the 4<sup>th</sup> Annual Veteran's Day Luncheon. He also mentioned concerns about the recent issues with E-bikes and electric scooters being used by children and the serious safety issues on the streets.
