President ProTem Steffanie Adams called the meeting to order at 6:30 PM. Clerk Bergeson called the roll noting a quorum was present. The Pledge of Allegiance was recited. Meeting was held at the Village Hall.

**Approval of the Meeting Minutes of October 14, 2025.** Motion to approve the minutes made by White seconded by Trustee Klouser. Motion approved with a unanimous "Aye" vote.

**Approval and Authorization for Payment of Bills**. Motion to approve payment of bills made by Trustee Adams, seconded by Trustee Culver. Motion approved by roll call vote as follows: Adams, Culver, Gonzalez, Johnson, Klouser and White: "Aye". Trustee Johnson. Motion carried.

Visitors who wish to address the Board (3-minute time limit). Resident Sharon Debo addressed the board with concerns regarding the drain behind public works. Mrs. Debo stated that there is a water coming out of the pipe behind the shop. She state that it smells like cleanser or oil, they are doing something. There is still standing water in the ditch. Regarding the adoption of the code of ordinances, Mrs. Debo asked who would enforce the ordinance? The reply was the Sheriff's department.

Consideration and Approval of Resolution 2025-05 to surplus the 2002 Pierce Fire Truck. Motion to approve made by Trustee White seconded by Trustee Johnson. The truck will be brokered for sale. Motion approved with a roll call vote as

follows: Adams, Gonzalez, Culver, Johnson, Klouser, and White voting "Aye". Motion carried.

Consideration and Approval of the Ordinance 2025-04 Adopting and Enacting a New Code for the Village of Hampton, Illinois; Providing for the repeal of certain ordinances not included therein; Providing a penalty for the violation thereof; Providing a manner of amending such code; and providing when such code and the Ordinance shall become effective. Trustee Klouser made a motion to approve the Ordinance, seconded by Trustee White. Motion approved by roll call vote as follows: Adams, Culver, Gonzalez, Johnson, Klouser and White "Aye". Motion carried.

**Discussion, Consideration and Approval of the quotes from Platinum for necessary computers and updates.** Motion was made by Trustee White, seconded by Trustee Gonzalez in the amount of \$3050.00 for the update and two (2) computers. Motion approved by roll call vote as follows: Adams, Culver, Gonzalez, Johnson, Klouser and White "Aye". Motion carried.

## **New Business & Committee Reports**

**Streets and Alleys:** Trustee Culver stated that she had nothing to report, she will look at the drainage issue that Mrs. Debo spoke about.

**Public Safety:** Trustee Johnson stated that the new fire truck fit nicely in the station. Nothing to report.

**Sheriff:** Lt. Chisholm stated that there is a lot of new deputies, as always if there are any concerns do not hesitate to reach out.

**Fire Rescue Chief Report:** Chief Manion stated the new engine is getting ready to be outfitted and the old 61 is out to be sold.

**Finance**: Trustee Adams stated that with the current government shut down, department heads should use caution when making purchases.

**Administration, Insurance and Code Enforcement:** Trustee Klouser stated that he felt we have met a huge milestone with regards to the Code of Ordinances.

**Public Works:** Trustee White stated that Alex with the village changed his meter. Trustee White stated that Alex is a good kid and the village made a great choice hiring him.
