President Christopher Bornhoeft called the meeting to order at 6:30 PM. Clerk Bergeson called the roll noting a quorum was present. The Pledge of Allegiance was recited. Meeting was held at the Village Hall.

**Approval of the Meeting Minutes of December 22, 2025.** Motion to approve the minutes made by Trustee Adams seconded by Trustee Klouser. Motion approved by voice vote. Gonzalez absent.

**Approval and Authorization for Payment of Bills.** Motion to approve payment of bills made by Trustee Adams, seconded by Trustee Culver. Motion approved by roll call vote as follows: Adams, Johnson, Culver, Klouser, and White: "Aye". Gonzalez absent. Motion carried.

**Visitors who wish to address the Board (3-minute time limit).** Nancy from MidAmerican addressed the board. Nancy informed the board of grants that are offered through MidAmerican. She will send the board the link.

**Consideration and Approval of sending a letter to the Rock Island County Road and Bridge (RICRB) and the Illinois Department of Transportation (IDOT), a letter affirming the town's intention to place a sign on a piece of property, adjacent to but outside the right-of-way for both RICRB and IDOT.** Motion by

Trustee Klouser, seconded by Trustee Johnson. Discussion as follows: Director Toalson will meet with Trustee Klouser to determine the exact location of placement and make sure it will not interfere with utilities. Motion approved by voice vote. Gonzalez absent.
