President Christopher Bornhoeft called the meeting to order at 6:30 PM. Clerk Bergeson called the roll noting a quorum was present. The Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Approval of the Meeting Minutes of June 8, 2026. Motion to approve the minutes made by Trustee Adams seconded by Trustee Klouser. Approved with unanimous voice vote. Gonzalez absent.

Approval and Authorization for Payment of Bills. Motion to approve payment of bills made by Trustee Adams, seconded by Trustee White. Motion approved by roll call vote: Adams, Culver, Johnson, Klouser and White: "Aye". Absent: Gonzalez absent. Motion passed.

Visitors who wish to address the Board (3-minute time limit). No one in the gallery.

Acknowledgment of correspondence from residents. Trustee Johnson received a message from resident Chris Larrison, he would like to know if the storm drains can be cleaned out. President Bornhoeft met with two of the partners that own the hardware store as to their plans. The hardware store is in bad shape.

Discussion regarding ADA requirements; moving council meetings, appointing coordinator. Trustee Adams spoke about the new ADA requirements. She is concerned with the struggles the village hall has being ADA compliant. Heritage Center is ADA accessible; however, a PA system would be needed. President Bornhoeft would like to explore options to make village hall ADA compliant.

Discussion, Consideration and Approval regarding raffle item for Hampton Days 2026. Trustee Gonzalez was absent and asked that this be brought to the next meeting. Motion by Trustee Adams, seconded by Trustee Culver to place on the next agenda. Motion approved by unanimous voice vote. Gonzalez absent.

Streets and Alleys: Trustee Culver spoke with MidAmerican and they cannot put maps together for the streetlight project. Trustee Klouser to go to county and get a map to mark out the need and placement of streetlights.

Public Safety: Trustee Johnson no updates.

Sheriff: Deputy reported all is quiet.

Fire Rescue Chief Report: Chief Manion absent.

Finance: Trustee Adams stated with the economy in complete chaos, please continue to be diligent with spending.

Administration, Insurance, and Code Enforcement: Trustee Klouser nothing to report.

Public Works: Trustee White nothing to report.

Public Works Director: Director Toalson reported that the decision was made for the full-time position in his department. Brennan Franklin "Bo" will be starting the 29th of the month.

Parks and Heritage Center: Trustee Gonzalez absent.

Village Clerk: Clerk Bergeson reported that the SWAG grant is completed. We purchased posts, signs and pet disposal bags for the heritage park along with smoker posts and compostable food containers for the Hampton days festival.

Deputy Clerk: Deputy Coberley has nothing to report.

President's Reports and Comments: President Bornhoeft attended an event with Senator Halpin and Representative Johnson who gave a legislation recap. Senate Bill 3484 takes effect January 1, 2027, for the regulation of electric bicycles. The bill regulates certain motor-driven cycles powered by electric motors exceeding 750 watts and certain gas-powered bicycles capable of speeds greater than 28 mph are subject to certificate of title requirements under the Illinois Vehicle Code.

Being no further business, motion to adjourn by Trustee Adams, seconded by Trustee White. Meeting adjourned at 7:23pm.
